

Contest rules

Early bird Trail permit

General rules

- 1. The *Early bird Trail permit contest*, hereafter the "contest", will be held from October 2nd, 2024 00:01 a.m. to December 1st, 2024 11:59 p.m., henceforth the "registration period", and is organized by the Fédération des clubs de motoneigistes du Québec, hereafter referred to as "the organizer."
- 2. The contest rules are available at the organizer's offices (101-1027 boul. des Entreprises, Terrebonne, Qc., J6Y 1V2, by phone at (514) 252-3076 or on the website www.fcmq.qc.ca.)
- 3. The contest is open to residents of the province of Quebec who are 18 years of age or older at the time of the contest.
- 4. The organizer's employees and members of the organization (administrators) and their family members are not eligible for the draws.

Mode of participation

5. During the registration period, described in point 1, the participant must visit the website of the Fédération des clubs de motoneigistes du Québec (www.fcmq.qc.ca) and purchase an annual trail permit or an antique annual trail permit in order to be automatically entered into this contest;

Period of participation:

- a) Between October 2nd, 2024 00:01 a.m. and December 1st, 2024 11:59 p.m. for a chance to participate in the prize draw, henceforth "participation period ";
- 6. During the registration period, from October 2nd, 2024 00:01 a.m. and December 1st, 2024 11:59 p.m., a person wishing to participate in this contest without the purchase of an annual trail permit or an antique annual trail permit must contact the Fédération des

clubs de motoneigistes du Québec at serviceclientele@fcmq.qc.ca and request a participation form. The form must be returned to serviceclientele@fcmq.qc.ca between October 2nd, 2024 00:01 a.m. and December 1st, 2024 11:59 p.m. or by the postal service at 101-1027 boul. des Entreprises, Terrebonne, Qc., J6Y 1V2 before December 1st, 2024 11:59 p.m., with the valid postmark.

- 7. All fields must be duly filled by the participant;
- 8. Participants can participate one (1) per registration period;
- 9. By fulfilling the above requirements mentioned in paragraphs 5 to 8, the participant is automatically entered into the contest.

Prize

Draw

- 11. Draws will be held on the Monday following the end of the contest at 10 a.m. at the organizer's offices.
 - December 2nd, 2024 at 10:00 am for the "participation period";
- 12. Winners will be contacted by email at the email address provided when they participate.
- 13. Winners must confirm acceptance of their prize within 3 business days of the organizer sending the email.
- 14. In the event that the above deadline is not respected, another draw will be held to determine a new winner.

15.	The prize will be sent to the winner's postal address (Quebec province only), following the
	acceptance of the prize and the completion of a discharge form.

Other conditions

- 16. The organizer cannot be held responsible in the event that the participant's contact information is inaccurate.
- 17. A dispute over the organization or conduct of a publicity contest may be submitted to the Régie des alcools, des courses et des jeux for a ruling. Any litigation respecting the awarding of a prize may be submitted to the Régie only for the purpose of helping the parties reach a settlement.
- 18. The organizer agrees to pay the delivery costs of the prices described in point 10, by a postal service to the winner's address as described in point 15.
